PRIVACY POLICY (Purpose of collection and use of personal information)

- 1. The purpose of personal information collection by 153/Joombas Music Group Co. - 2. 153/Joombas shall not use or provide applicant's personal information to third parties for any other purpose other than for the intended collection of information and will not use the collected information for any purpose without the consent of the applicant.
- 3. 153/Joombas may collect and use personal information for the following purposes. However, if collection / storage of personal information is deemed inevitable in accordance with relevant laws and regulations, the relevant information can be collected by notifying the user..

 - 3. Optional Information
 - Audition Experience & Activities & Awards: For Audition Evaluation References
 - 4. Others
 - During the audition, the following personal information mentioned in the above and in the below can maybe collected.
 - Family History, Individual History, Medical Records: Additional elements for assessment with Applicants' capability
- 4. 153/Joombas shall not collect and use the personal information of the children under the age of 18 without the express written consent of the appropriate legal representative. Such applicants will need to fill out the Legal Representative Agreement with the valid legal representative or guardian's signature in order for 153/Joombas to collect and use applicant's personal information.  - Must Submit 3 demos: at least 1 demo has to be done completely alone (or as a team) (*Required;)
 - Instrumental only (MR) is also acceptable
- 2. Topliner
 - Must Submit 3 demos at least 1 demo has to be done completely alone (or as a team) (*Required;)
 - · Full demo including recorded topline on completed tracks
 - 💥 It is acceptable to NOT have lyrics for topline melody demos, but additional points will be considered if lyrics are included.

Eligibility Requirements

There is NO age limit.

(However, if the person is under the age of 18, must have legal representative or guardian's signature and agreement when signing the Final Agreement)

- ▷ Individuals / Teams can participate (only applications; all other documents <u>MUST</u> be submitted separately for teams)
- If submitted demos are the result of collaborations or teamwork, please include the specific credits for each part (ex: Topline: A, Production: B)
